सोशल मीडिया मंचों ने दिल्ली हाई कोर्ट को बताया

मृत महिला को बलात्कार पीड़िता के रूप में दिखाने की भूल सुधारी

नई दिल्ली, 28 जनवरी (भाषा)।

सोशल मीडिया मंचों फेसबुक, गूगल और ट्विटर ने गुरुवार को दिल्ली उच्च न्यायालय को बताया कि उन्होंने उन सभी लिंक को हटा दिया है या उन्हें अवरुद्ध कर दिया है जिन पर हाथरस बलात्कार पीड़िता के रूप में एक मृत महिला की फोटो को गलत तरीके से दिखाया गया था। न्यायालय ने 23 नवंबर, 2020 को वे सभी लिंक हटाने के निर्देश दिए थे जिन पर हाथरस बलात्कार पीड़िता के रूप में एक मृत महिला की तस्वीर को दिखाया गया था। इन निर्देशों पर तीनों सोशल मीडिया मंचों ने न्यायमूर्ति प्रतिभा एम सिंह को यह जानकारी दी।

उच्च न्यायालय ने 23 नवंबर के अपने आदेश में कहा था कि पीड़ित व्यक्ति से नए लिंक पर नजर रखने और हर बार शिकायत करने की उम्मीद नहीं की जा सकती और इस समस्या का स्थायी समाधान किए जाने की आवश्यकता है। न्यायालय ने यह टिप्पणी उस व्यक्ति की याचिका पर सुनवाई के दौरान की थी जिसने दावा किया है कि सोशल मीडिया पर उसकी मृत पत्नी की तस्वीर को हाथरस बलात्कार पीड़िता की तस्वीर बताकर वायरल किया गया। सुनवाई के दौरान गुरुवार को इस व्यक्ति के वकील ने अदालत को बताया कि आपत्तिजनक सामग्री के सभी लिंक फेसबुक द्वारा नहीं हटाए गए हैं और मौजूदा लिंक/यूआरएल को रिकॉर्ड करने के लिए समय मांगा। इसके बाद अदालत ने उन्हें 12 अप्रैल तक का समय दिया, ताकि वह उन लिंक/यूआरएल को रिकॉर्ड कर सके, जिन्हें हटाया जाना बाकी है। हाथरस निवासी कथित सामूहिक बलात्कार पीड़िता की 29 सितंबर, 2020 को दिल्ली के सफदरजंग अस्पताल में मौत हो गई थी।
